The St. Martin Parish Library Board of Control met on Monday, October 7, 2024 at 5: 00P.M. at the St. Martinville Branch Library. President Romero called the meeting to order at 5:06P.M. Parish President Pete Delcambre gave invocation. Mike Foremeller led the Pledge Allegiance. Secretary recorded attendance. Members present were Tommy Romero, Chenita Broussard, Charlene Leblanc and Mike Formeller. Georgie Blanchard, Henry Derouselle and Freda Harrison was absent.

Also in attendance: Parish President Pete Delcambre, Parish Council Chairwoman Carla Jean Batiste and St. Martin Parish Fire Chief Brody Miller

On a motion by Mike Formeller and a seconded by Charlene LeBlanc, the minutes of the August 5, 2024 were approved unanimously.

**Public Comment:** None

**Unfinished Business: Tax Millage**

Parish President Pete Delcambre provided an explanation of all the tax propositions that will be on the November 6 and December 7, 2024 election ballots. He stressed the importance of each tax millage renewal and services provided by each.

Surplus Property in Storage at Acadiana Movers/All American Transfer was discussed. The furniture was offered to the City of St. Martinville, the School in St. Martin Parish, and other entities. No one wanted the furniture. Mike Foremeller moved to have Acadiana Movers/All American Transfer dispose of it for \$2,610.00, seconded by Chenita Broussard, and approved unanimously.

**New Business:**

Parks Branch Library:

There was a lengthy discussion on the Parks Branch Library. The process of securing the property from the Village of Parks to St. Martin Parish Government has identified phases. This property was donated exclusively for the purpose of building a library. Parish President Pete Delcambre will consult with Lee Durio, Parish Attorney regarding the process and report back to the Director and Board.

In the Director's update Mrs. Charlar Brew informed the members about the programs and activities being held at the Branches and materials being sent to Stephensville/ Bell River. She informed the members of the new program Check Out Louisiana State Parks and Historic sites being conducted through the State Library. More information is available in all library branches. Members were given copies of the financials for September.

**Good of the Order:** Members were thanked for their support and dedication to the Library Board.

The next scheduled board meeting will be on November 4, 2024. Being no further business, Chenita Broussard moved that the meeting be adjourned and Charlene Leblanc seconded. It was approved unanimously.
